Bureau Veritas, as a trusted third party, will contribute to updating the Group's guide to Hygiene, Safety and Environment (HSE) practices used in its European centres, based on the latest recommendations of health authorities. For the first time in the Group, this will be done with the assistance of epidemiologists. Bureau Veritas will then conduct an audit of all URW's European shopping centres in order to label them.
