Paris, June, the 24th. As the International Paris Air Show (Paris-Le Bourget, June 17 to 23, 2019) draws to a close, **Bureau Veritas** announces that it has signed a framework agreement with the **Safran Group** for inspections of its technical facilities. The three-year contract will allow Bureau Veritas to work on Safran Group sites in France and abroad.
